**III. FOX FULLERTON THEATRE TOUR**

The Fox Fullerton Theatre was built in 1925 by Charles and Stanley Chapman. Designed by the firm of Meyer & Holler, who also designed Grauman's Egyptian Theatre and Grauman's Chinese Theatre, both in Hollywood. The Fox Fullerton Theatre became Orange County's first movie palace. The venue hosted live vaudeville performances, community events, stage concerts, and screenings of Hollywood's finest silent films. The Fox Fullerton Theatre was added to the National Register of Historic Places in October of 2006. This tour will cover many areas throughout the site, including the balcony, projection booth, stage, exterior entry courtyard, and the Tea Room.
